Expression of Interest (EoI) for Procuring Sports Surfacing Materials

Government of Kerala is hosting 35th National Games in year 2010-2011. National Games Secretariat created by Government of Kerala for carrying out this mission, have undertaken the ambitious programme of renovation of existing sports facilities and the construction of new facilities across the state of Kerala to raise it to International Standards.

Part of the above construction programme involves Design and Supply of Materials, Installations, and getting approval from competent authority for various sports surfaces for the field of play of Sports Arenas. The following sports surfaces are identified for installation.

- Synthetic surface for Hockey.
- Wooden flooring for Indoor sports.
- Synthetic surface for Tennis
- Synthetic surface for Athletic track.
- Synthetic surfacing for Lawn Bowl (outdoor)

The above work comprises of construction of sub base work, drainage facilities, fencing, earthwork, Asphalt work, etc. The specialised synthetic surface construction comprise of Design, Selection of materials, Testing of all materials through accredited laboratories, installation of synthetic surface as per approval guidelines of the respective international federation or the body governing the rules of the sport, and performance Testing. The approval from the respective International Sports Federation in writing.

Expression of interest is invited from eligible and qualified manufacturers of the synthetic surfaces / specialised surfaces for the items listed above and fulfilling following terms and conditions.

1. The product / Brand proposed by the manufacturer must be included in the approved list of vendors published by the respective International Sports Federation.
2. The manufacturer of the product / brand must have a registered manufacturers' representative office in India – with valid address. The said representative shall have a clear power of attorney from the manufacturer authorizing him to carryout sports surface laying in India.

3. The product / brand must have been installed in reputed Sports Organizations / National level institutes in India. They must have installed at least one such installation during the last 3 years.
4. The manufacturer must be able to undertake and organise the laying of sub base and allied civil construction work along with construction of the specialised surface.
5. The product / brand must be guaranteed for tropical climate like coastal region of Kerala and ensuring long service life without deterioration due to climatic conditions.
6. The scope of the specialised surface is approximately quantified as follows against the venues noted.
